Recently the <u>Patient ID Now</u> coalition, a group of more than 50 organizations in the healthcare industry including health IT associations, vendors, providers, patient groups, and public health organizations, worked with Reps. Mike Kelly (R-PA) and Bill Foster (D-IL) to introduce a piece of bipartisan legislation into the U.S. House of Representatives entitled the <u>Patient Matching and Transparency in Certified Health IT (MATCH IT) Act of 2024</u>. The MATCH IT Act would address the problem of patient misidentification within the healthcare ecosystem while improving patient safety and privacy by creating an industry standard definition for the term "patient match rate." This industry standard will allow measurement of patient match rates across the healthcare system and improve standardization of patients' demographic elements entered into certified health IT products; helping to ensure patients are accurately matched to their medical record.
