Presentation 2: Social Determinants of Health: Homelessness – Government payer policies, revenue opportunities, and current state of analyses

Summary: Mass General Brigham (MGB) first implemented the Social Determinants of Health (SDOH) Screening tool across ambulatory clinics in March 2018. Since then, it has expanded to most ambulatory and select specialty outpatient departments; as February 2024 the SDOH screening tool was adapted and launched across our hospital inpatient settings.

Learning objectives:

1. Understand how CMS's strategic refresh has focused attention on health equity and is driving policy changes and influencing MGB's SDOH strategy,

- 2. Build awareness of validated analysis, its impact, and identified revenue opportunities with key leaders to support improvement opportunities.
- 3. Understand how and where SDOH is captured from patients in Epic and the current state of coding SDOH.

<u>Kameron Knab, MHA</u>, Director of Government Payer Policy, Mass General Brigham Kam Knab is the Director of Government Payer Policy at Mass General Brigham. In this role, Kam works with the health system, hospital, and physician organization finance teams to drive the overall revenue strategy for the health system and with the value-based care leadership team to shape the risk contracting approach for the organization. Prior to MGB, Kam was a consultant with Manatt Phelps Phillips, a law firm specializing in CMS waivers and Medicaid reimbursement and a Fellow at

Maryland's Health Services Cost Review Commission (HSCRC). Kam and his husband can be found hiking on the weekend with their two dogs or gardening.



<u>Shalina Patel</u>, Project Specialist, Social Determinants of Health and Health Equity, Office of the Chief Medical Officer, Mass General Brigham

Shalina is a Project Specialist in Health Equity within the Office of the Chief Medical Officer (OCMO) at Mass General Brigham. Shalina manages the Social Determinants of Health Program where she sets system-wide strategies for screening and responding to health-related social needs. She ensures the program meets new regulatory requirements under Joint Commission, CMS, and additional

Massachusetts-based requirements. She is responsible for executing strategy through the expansion of SDOH screening across the system and developing standard measurement of SDOH data collected. She is also managing 5 project teams within the United Against Racism Clinical Equity Improvement Program, aiming to foster a community of quality improvement with a health equity focus and reduce health disparities in the specialty departments. She is currently a Master's candidate at Brown University and received her Bachelors in Health Services Management and a certificate in Health Information Management from East Carolina University.
