Title: Health Information Privacy and Security In the Era of Artificial Intelligence

Presenter: Colin J. Zick, Partner, Foley Hoag LLP

Colin Zick's practice is focused on healthcare and compliance issues, and often involves the intersection of those two subjects in investigations, administrative proceedings, or litigation. His work has had a particular emphasis on compliance issues related to life sciences, pharmaceutical and medical device companies, laboratories, hospitals, healthcare providers, and provider organizations.

Summary: Data privacy has increasingly become a matter of concern in the era of large public digital repositories of data. This is particularly true in healthcare where data can be misused if traced back to patients, and brings with itself a myriad of possibilities. Al also brings increased threats to data security. Custodians of health information have ethical and legal constraints for data access sharing.

What sets Grace's podcast apart is the intentional inclusion of women patient & caregiver leaders in the dialogue – oft overlooked perspectives.
