Title: Evolution of query workflows: Computer Assisted Physician Documentation (CAPD) and advanced Artificial Intelligence (AI)

Summary: Query workflows require a delicate balance. We must be mindful of physician burnout and administrative burdens, while also addressing ever-increasing demands for documentation that is complete and compliant, supports financial and quality goals, and mitigates the risk of denials due to stringent payer rules.

In this session, we will discuss the evolution of the query and how today's CDI and coding teams are using AI to automatically deliver clinical intelligence into physicians' documentation workflows. We will discuss manual queries and AI-powered CAPD nudges and examine industry guidelines around content and templates as well as delivery and response methods. Title: Important Health Privacy Developments: HIPAA's Reproductive Health Information Protections and the Single TPO Consent under 42 CFR Part 2

Presenter: Dena Castricone, CIPP/US, CIPM, Privacy and Healthcare Attorney, Managing Member, DMC Law, LLC **Summary:** It's been quite the year for developments in health privacy law. So far this year, there have been two major final rules from the Department of Health and Human Services (HHS) relating to health privacy. First, in February, HHS issued the most sweeping changes we have seen to 42 CFR Part 2 in an attempt to align it more with HIPAA and to relieve the burden on sharing Part 2 information for treatment, payment and healthcare operations (TPO) purposes. Next, in April, HHS released a final rule on the protection of reproductive health information just one year after its proposed rule. We will focus on the single consent for treatment, payment and healthcare operations under the revised 42 CFR Part 2 and the revisions to HIPAA regarding the protection of productive health information. Specifically, we will:

- Take a high-level look at the changes to 42 CFR Part 2
- Scrutinize the new single consent for TPO requirements
- Briefly review the new requirements regarding the protection of reproductive health information
- Examine HHS' Model Attestation (released in late June)
- Explore a decision-tree model for walking through the new requirements
- Consider how the April 2024 Final Rule provides insights on the timeline for pending HIPAA changes

Title: OIG Work Plan: A CDI-Focused Examination of Compliance Priorities

Summary: The Office of Inspector General (OIG) regularly focuses its auditing efforts on high-dollar, high-quality clinical conditions at risk of being incorrectly documented and/or coded. Understanding the OIG focus areas can help CDI programs protect their organizations against compliance risk, educate providers, and conduct internal auditing to ensure their organization does not become a post-payment statistic. Participants will learn the new, updated, and ongoing target areas applicable to Medicare Parts A and B that have been selected for elevated enforcement. New target areas will be specifically discussed, and attendees will walk away with recommendations for assessing and reducing post-payment risk associated with OIG target areas. '
