## FINANCE REPORT – FISCAL YEAR 2019 (JULY – DECEMBER 2019)

I would like to preface this report with a comment about what we can expect regarding MaHIMA's financial situation as we all deal with the changes in both our personal and professional lives during the COVID-19 pandemic. While face to face meetings are not an option for the foreseeable future, we are increasing the number of webinars being offered as an alternative and will be taking a close look at expenses. The annual meeting has been moved to early October. These changes will impact both this year's budget as well as FY 2021. AHIMA is providing assistance to the CSA's on evaluating our budgets and sharing ideas of what we can do to get us through this period. Each quarter the finance report ends with a status of our balance sheet and what we currently have for reserves. This current situation is exactly why we maintain a reserve fund to be able draw on money as needed in the short term to cover expenses until income is generated to cover them. ## NORTHEAST PHYSICIAN HOSPITAL ORGANIZATION (NEPHO) TELEHEALTH PROGRAM REVIEW- COVID 19

NEPHO supports over 350 providers as they navigate through the business of healthcare. NEPHO helps with negotiations of commercial insurance contracts, handles the provider's initial health plan enrollment with contracted payers, helps to process patient insurance referrals from PCPs to Specialists, and provides coding and billing support.

Telehealth came fast and furious the last few weeks of March 2020. NEPHO had been working a telehealth pilot program that was funded by the 2019 Harvard Pilgrim Quality Grant Award. The funding helped to implement telehealth services in 4 of their practices that included; Northeast Dermatology Associates, Cape Ann Medical Center, North Shore and EMG, LLC, and Danvers Family Doctors, PC. There were many lessons learned during the first few quarters of the program development but nothing on the radar prepared NEPHO for the COVID 19 crisis that would change telehealth across the country. <u>Read more here.</u>

With the increased number of cases of COVID-19 at Massachusetts hospitals, and the need to comply with government orders regarding social distancing, we reached out to some of our local HIM directors to see how they were handling the challenge.
