MAHIMA SUMMARY: HOD BREAKOUT SESSION

HOD Summary Breakout Session: The role of the HI Professional in Shaping Health Equity

The following hypothesis was presented: If the Final ONC 2020-2025 Health IT Strategic Plan does not include language to support a bidirectional infrastructure, the promise of whole person healthcare will not be achieved.

We discussed the primary HIPAA barriers at length as the families of Pandemic patients are not getting the information for their loved ones as easily due to the HIPAA guidelines. Utah and So Dakota have Programs where the Community Health Centers are more active in getting authorizations for significant partners for information sharing, and suggested this active participation become a priority industry-wide, and addressing the community needs by working with the food banks and beneficiary programs in unity versus silo activities.
