AHIMA 2024 Advocacy Summit & Hill Day

On March 11th and 12th, four MaHIMA members headed to Washington DC for the annual two day AHIMA Advocacy Summit and Hill Day. Led by Amy Bittle, MaHIMA's Advocacy /Legislative Chair and fellow MaHIMA members Deb Adair, Melissa Young, Lisa Chapelaine and Maryellen Osborne represented AHIMA for the visits with our two Massachusetts Senators in the US Senate and three Massachusetts Congressmen from the US House of Representatives.

This event, as always, is a great learning experience regarding Advocacy especially related to our profession as well as the experiences of meeting with our own state senators and congressmen's staff to discuss two key topics that were raised by our AHIMA colleagues across the country. Not only were we able to connect with the teams supporting our state on the national level but we were able to share experiences about Advocacy, our individual states and common life themes. Also, it was wonderful for Amy, Melissa, Deb, Lisa and I to communicate with each other in person rather than by phone, Teams or Zoom. We all appreciated this perk. Update Regarding AHIMA 40% AHIMA CEU Resistance by CA's

At the moment, AHIMA still plans to implement the requirement that 40% of all member's required CEUs be of educational programs sponsored by AHIMA in 2025. Despite a letter writing campaign to AHIMA Leadership and the new CEO, as well as close to 8000 signatures on the change.org petition, AHIMA's position has not changed.

However, the Component Associations or CAs, including MaHIMA, remain active in taking additional steps to change or eliminate this requirement. Current activities include a request to have a meeting with the new CEO and the potential creation soon of a small subgroup from the CAs to develop the following AHIMA bylaw changes: including CAs and ACEP along with AHIMA within the 40% requirement; developing a bylaw amendment that member and CA feedback must be considered in decisions that change agreed upon certification requirements in the

future; and scheduling a meeting with AHIMA leaders and CCHIIM as per AHIMA bylaws – "CCHIIM has sole and independent authority in all matters pertaining to the certification and recertification activities of health informatics and health information professionals." There is more work ahead and I am hopeful for a positive outcome given the solidarity of the CAs. The MaHIMA board and I will remain active and keep membership appraised of any new activities.

2024/2025 MaHIMA Elections

We will not be having our annual elections this April, despite our attempts to find candidates to run for our President-Elect and Director of Communications positions.

Over the last few years, it has become increasingly difficult to find candidates for our elected Board of Directors positions as well as volunteers to support our officers, directors, and support staff. WE NEED YOU!

Although we appreciate all the MaHIMA members who currently hold office or serve on committees or individual projects, we need more volunteers!
